



**Rules for Young Scientists' Award of the
International Conference on Development and Applications of Nuclear Technologies
NUTECH 2023**

§. 1. Founders

Organizers of the NUTECH 2023 Young Scientists' Award Competition is Scientific committee of the conference. The founders of the rewards are co-organizers of NUTECH 2023 Conference are:

- **Institute on Nuclear chemistry and Technology (INCT), Dorodna 16, 03-195 Warsaw, Poland**
- and
- **Polish Nuclear Society (PTN), Dorodna 16, 03-195 Warsaw, Poland.**

There are three awards for best posters founded by the INCT:

1. First award – 1000 PLN
2. Second award – 600 PLN
3. Third award – 300 PLN

and three awards for the best oral presentations founded by the PTN:

1. First award – 1000 PLN
2. Second award – 600 PLN
3. Third award – 300 PLN

All winners will also receive commemorative diplomas.

§. 2. Rules of granting

1. Young scientists (undergraduate, graduate and PhD students) who are below 35 years old or max 5 years after defending their doctorate, are eligible to participate in the competition.
2. The competition is open to those young scientists who, on the first day of the conference (20th of September 2023), declare their willingness to participate by competing application form (attachment 1).
2. The competition is open to young scientists whose abstracts have been accepted as both oral or poster presentations and who will present their studies during Conference Session or Poster Sessions.

§. 3. Awards

The awards for the best presentations will be selected by scientific jury and announced during the Closing Ceremony.

The awards will be given in cash during Closing Ceremony. Awarded scientists are not obliged to pay income tax in Poland (Journal of Laws 2022.2647, article 21, point 68).

§. 4. Selection committee

1. The Selection Committee consists of members of the Scientific Committee of the NUTECH 2023:

- Prof. Grażyna Zakrzewska-Kołodziej (INCT) – chairman of the committee
- Prof. Marek Lankosz (AGH)
- Prof. Jerzy Cetnar (AGH)
- Prof. Suresh Pillai
- Prof. Xavier Coqueret

2. The secretary of the selection committee will be dr. Urszula Gryczka (INCT).

3. All members of the Selection Committee agreed to take part in the Committee works.

3. Each member of the jury selects the 10 best posters in his/her opinion and assigns them a score from 1 to 10, where 10 means the best poster. The submitted works will be evaluated taking into account scientific content, originality of the research and clarity of presentation.

4. The final result of evaluation process is the sum of points given by particular member of jury to individual posters. If the presentations receive the same number of points, the ranking will be decided by the committee.

§. 6. Final remarks

1. In matters not covered in this rules, the decision will be made by the Chairman of the Selection Committee.

2. Organizers reserve the possibility to make changes or introduce additions to the rules of Young Scientists' Award of the International Conference on Development and Applications of Nuclear Technologies NUTECH 2023.

Your personal data is processed on the basis of Article 6(1)(b) GDPR in order to carry out the process of evaluating competition applications, to carry out the competition in accordance with the content of the regulations and to inform the Controller, if any, about the fact that you have been awarded a prize; on the basis of Art. 6(1)(c) GDPR, if in connection with the awarding of your prize it will be necessary to fulfill legal obligations incumbent on the Controller; on the basis of Art. 6(1)(f) GDPR in order to pursue the legitimate interests of the Controller, whereby the Controller legitimate interest is the defense against potential claims.
Recipients of your personal data will be only entities authorized to obtain personal data under the law (e.g., courts, tax authorities) and entities participating in the implementation of services for the Controller, such as providers of IT solutions, legal services or insurance company. Data may also be shared with entities supporting or contracting the Controllers activities (verification, evaluation, monitoring).
Your personal data will be stored for the period necessary for the selection of contest winners and the awarding of prizes in the contest; data may also be processed for the period of fulfillment of legal obligations by the Controller.
You have the right to request from the Controller access to your personal data, the right to rectify, erase or restrict processing, the right to data portability. You also have the right to object to processing based on the legitimate interests of the Controller - on grounds relating to your particular situation. You have the right to lodge a complaint with a supervisory authority.
Your provision of personal data is voluntary, however, necessary for participation in the competition.
